Q: Do I need a referral for an assessment?

A: No, individuals can self-refer to Brilliant Minds Psychology for any assessment.

Q: Am I able to receive a medicare rebate for assessments offered at Brilliant Minds Psychology?

A: Unfortunately, Medicare does not currently provide rebates for cognitive/behavioural assessments. However, if you are doing a comprehensive Autism Assessment and have been referred by a Paediatrician, you will be eligible to receive a rebate of \$93.35 for up to 4 sessions if a specific referral for an autism assessment has been provided.

Q: If I have Private Health insurance, am I able to use my Private Health for assessments? A: Yes, you may be eligible to claim a rebate from your Private Health insurance provider. However, we do recommend you contact your provider for information regarding whether or not you will be eligible in making a claim for an assessment. The Private Health item number for assessment is 100.

Q: How long will it take until the assessment report will be ready?

A: There is a two to four-week turnaround for all reports as the clinician will spend time after the assessment interpreting, scoring, analysing and writing up the report. If there is a delay in receiving completed questionnaires from parents/guardians and/or teachers, there will be a longer turnaround timeframe. You will be informed of this at the time of booking an assessment.

Q: Can I use NDIS funding to cover the costs of the assessment?

A: We ask that you check your plan to ensure that your NDIS plan covers assessments. It is the duty and responsibility of the participant to ensure that their funding can be used for the purposes of assessment. Please note the fees above are for clients who are paying privately or are NDIS Self-Managed. We are not a NDIA Registered Provider.

Q: Do you offer in clinic assessments?

A: Yes - please ask the client services team to send you the in-clinic packages.

Q: What are your payment methods?

A: Our payment methods are as follows:

- NDIS Self or Plan Managed
